The Hall Rental Fee is \$375.00 with a \$100.00 non-refundable deposit to hold the date. The balance is due the day of the party/event. All monies are to be paid **in CASH or CHECK ONLY**. Post 7275 does not accept **ANY CREDIT CARDS**.

All ALCOHOLIC BEVERAGES MUST be purchased thru Post 7275 Bar and consumed with in the Bar and Hall as per SLA and Insurance Laws. **No Outside Alcoholic Beverages** can be consumed in the hall, bar, or parking lot areas as per SLA and Insurance Laws. Post 7275 can customize a bar package to fit the renters needs: Cash Bar, Bar Tab, etc....

SHOTS WILL NOT BE ALLOWED to be put on a **BAR TAB** but can be purchased thru the bar **CASH ONLY**.

The Hall Rental includes the use of the Hall during normal business hours. The Hall has a separate ground level/no step entrance/exits and restrooms. **Post 7275 supplies:** tables, chairs, garbage cans and liners, 12oz and 7oz cold cups, pitchers, ice, and ice buckets, and use of a 60-cup coffee urn and filters. **Renter is responsible for everything else:** Coffee, sugar, creamer, hot cups, table clothes, plates, napkins, silverware, serving utensils, chaffers, roasters, crock pots, etc.... **Renter is responsible to** is set up tables and chairs and decorating. Please do not tape or pin anything to walls but you can tape to the picture frames or mirrors. **Renter is responsible to** clear all garbage-to-garbage cans and remove all items brought in after event/party. **Post Staff will put away tables and chairs. Post Staff cleans & sanitizes all tables and chairs after each event.** **Renter can** bring in own food. Drop off catering, Delivery, or brought/cooked from home is allowed. **Renter cannot** use Post 7275 Kitchen facilities or equipment as per SLA, Insurance, and Erie County Health Dept.

AS PER SLA AND INSURANCE NO ALCOHOLIC BEVERAGES ARE TO BE CONSMED OUTSIDE THE HALL OR BAR AREA. NO ALCOHOLIC BEVERAGES ARE ALLOWED FROM OUTSIDE SOURCES. ALL ALCOHOLIC BEVERAGES MUST BE PURCHASED FROM POST 7275 BAR. NO ONE UNDER THE AGE OF 21 IS ALLOWED TO CONSUME ANY ALCOHOLIC BEVERAGES. POST 7275 RESERVES THE RIGHT TO PROOF ANY OR ALL GUEST. FAILURE TO COMPLY WILL RESULT IN BEING ASKED TO LEAVE THE PREMISES AND OR IMMEDIATE TERMINATION OF EVENT/ PARTY.

Renter can bring in own pop, water, or any other **NON-ALCOHOLIC BEVERAGE** to be consumed in the hall. Hall/Bar pricing on pop: pitcher \$8.00 16oz glass \$2.00 bottled water \$1.00 pitcher of tap ice water no charge.

Entertainment: Band, DJ, Raffles or Drawings are subject to the approval of the Bar Steward to ensure that it meets the requirements of the SLA, Health Dept., and Insurance qualifications.
